WHAT ARE MY OPTIONS AFTER I GRADUATE?

Post Graduate Open Work Permit

General criteria:

1. graduate of a public post secondary institutions or private university (degree holder)
2. >8 months full time study program, continuously
3. valid study permit at the time of application + 180 days after completion of program
4. maintained full-time student status in Canada during each academic session of the program
5. Received a transcript and an official letter from the eligible DLI confirming that they have met the requirements to complete their program of study.

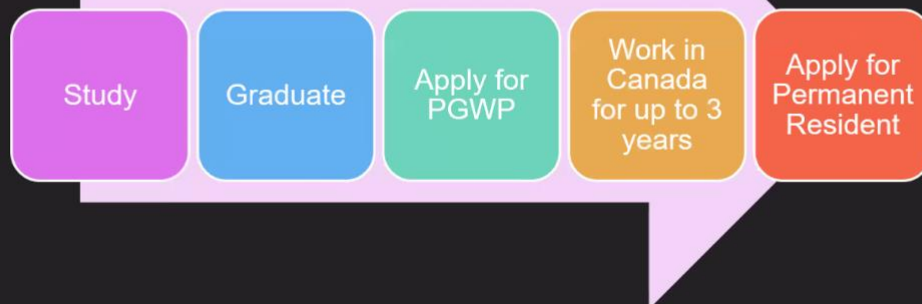

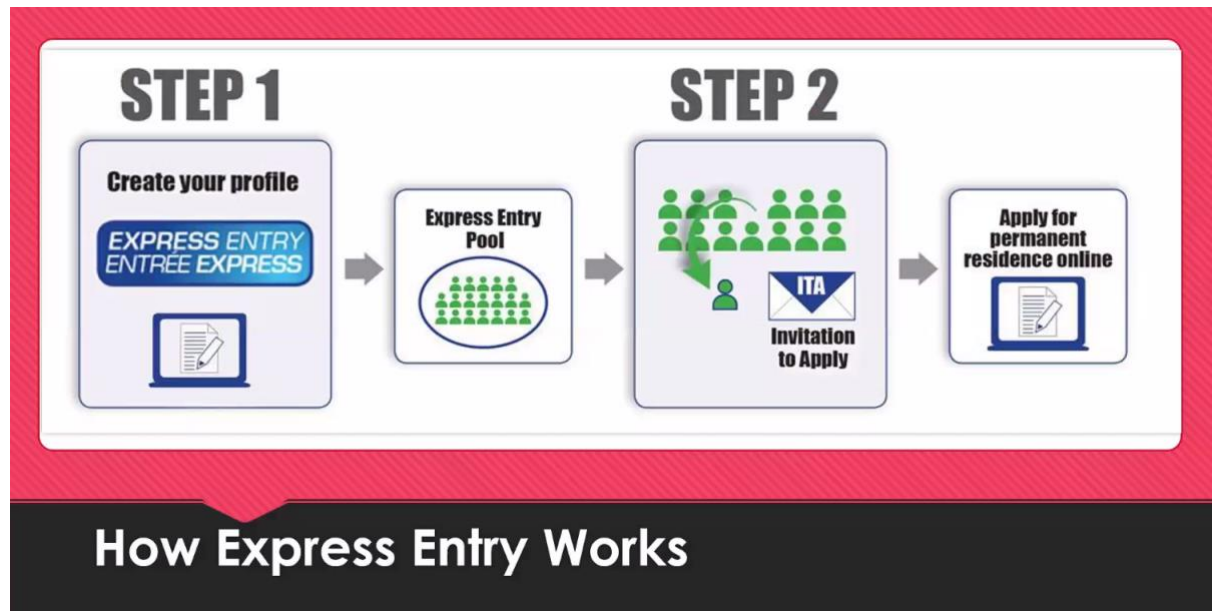
What is Express Entry System?

Canada chooses skilled immigrants as permanent residents based on their ability to settle in Canada and take part in Canada's economy.

The system to manage how people with skilled work experience apply to immigrate to Canada is called

Express Entry.

Express Entry - Meeting Eligibility

Federal Skilled Worker

Canadian Experience Class

Federal Skilled Trade Worker

- 
1. 1 year or more high skilled, full time work experience in Canada (authorized), in the last 3 years
 2. Attained English/French scores associated with the specific job level through approved language test

What Contributes to Express Entry Points?

The CRS gives you a score from the information in your profile, including your:

- Age
- education
- language ability
- work experience
- Adaptability factors

You can also get more points for having:

- Canadian degrees, diplomas or certificates
- a qualified job offer
- a nomination from a province or territory
- Siblings who is Canadian Citizen or Permanent Resident
- French as Second Language

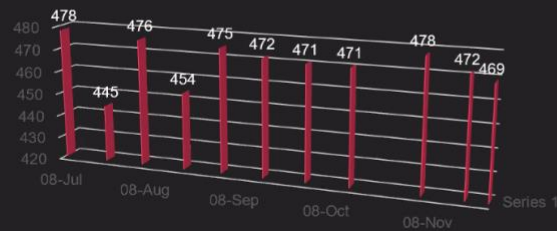

The next minimum cut off score can only be predicted based on historical data

Sample scenarios

The New Grad

- Bachelor's Degree from Canadian Institution
- English CLB 9 (IELTS Listening 8.0, Reading 7.0, Writing 7.0 and Speaking 7.0)
- 1 year skilled work in Canada
- 25 years of age, single
- No work experience outside of Canada

Estimated score = 462

The Young Professional

- Master's Degree (foreign credential)
- English CLB 9 (IELTS Listening 8.0, Reading 7.0, Writing 7.0 and Speaking 7.0)
- 3 years high skilled work experience outside of Canada
- 34 years of age, single
- No work experience in Canada

Estimated score = 442

The Experienced Worker

- Bachelor (foreign credential) and Diploma from a public Canadian Institution (1 year)
- English CLB 7 (IELTS Listening 6.0, Reading 6.0, Writing 6.0 and Speaking 6.0)
- 1 year skilled work in Canada
- 40 years of age, married
- 3 years work experience outside of Canada

Estimated score = 398

What happens if you don't have enough scores to get invitation (ITA)??

PROVINCIAL NOMINEE PROGRAM

British Columbia Provincial Nominee Program [BCPNP]

Express Entry BCPNP (Online PR)

BCPNP profile must be connected to EE profile

Successful nomination will add 600 points to EE profile

PR is submitted online (EE)

PR processing time = 6 months

Candidate must meet eligibility criteria of FSW, CEC or FST during profile creation

Skills Immigration BCPNP (Paper PR)

No Express Entry profile

After successful nomination, PR must be submitted by paper

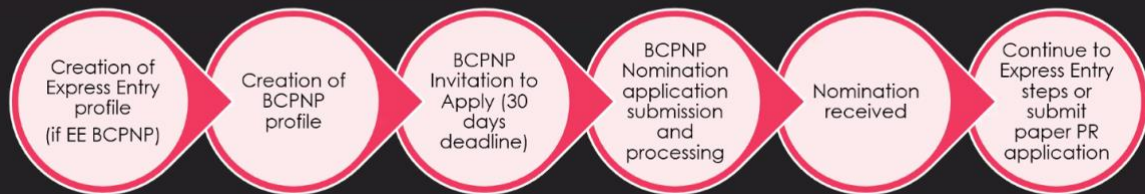
PR processing time = 1.5 – 2 years

Candidate does not need to meet the eligibility criteria of FSW, CEC or FST at any point

Nomination processing time = same as EEBCPNP

Parents and Grandparents

Super Visa

1. Permanent Resident or Citizen of Canada
2. Proof of funds
3. Have a medical insurance from a Canadian Insurance company (valid for 1 year with at least 100,000 coverage)
4. Medical Exam required

Parents and Grandparents Sponsorship

** New policies apply in 2019*

1. Quota increase from 10,000 to 20,000
2. Expression of Interest
3. First come first serve
4. LICO +30% for the last three years
5. Co-signer must be a spouse

Who can help me with my applications?

- Only some people can charge you a fee or receive any other type of payment. These people are called "authorized" representatives. They are:
 1. citizenship or immigration consultants who are members in good standing of the Immigration Consultants of Canada Regulatory Council
 2. lawyers - members in good standing of a Canadian provincial or territorial law society
 3. notaries - members in good standing of the Chambre des notaires du Québec

Canadaian Immigration Systems tidak menganggap punya property sebagai penambah point.

Jadi gak ada hubungannya property dg syarat apply PR.

Kalo anak udah sekolah di Canada, dan ke tempat terpencil memang akan menambah points tapi tidak significant.

Yang penting lulus dari sekolah di Canada, Language test, punya pekerjaan working experiences

Kalo punya PR, dapat akses healthcare systems. Cukup bayar tax dan dapat healthcare facilities
kalau qualified sebagai Canadian Citizen maka dapat hold Canadian Passport

Kalo anak lulus, tidak hrs kerja di sesuai bidang studi utk apply PR

Di Alberta ada option kalau lulus hrs kerja di sesuai bidang studi

Yg penting hrs kerja di level NOC yang telah ditentukan di atas

Hrs ada akumulasi canadian working experience nya 1,5 thn bisa apply federal level

Kalo Co-Op program as maintain full time student status

Input penting dari Pak Gadjah:

Work experience has to fulfil 1560 hours, full time 30 hours/week sekitar 1 year, atau 15 hours/week part time sekitar 2 years.

selama programnya masuk sbg program sekolah, tidak akan mengurangi jatah PGWP (mis exchange student, CoOp dll). tapi harus diurus dng counselor.

Job hours will be calculated after student receive Certificate of Completion (lulus).

Invitations Round statistic, adalah score yg menerima ITA (Invitation to Apply), yang lolos diterima.

kalau PNP harus stay / study sesuai Province yg diapply.

Kalau ambil certificate, misalnya utk actuarial, apakah bisa menambah point PGWP ?

Jawab

tidak langsung pak menambah score, hanya mungkin akan mempermudah mendapatkan job.

PGWP hanya bisa dilakukan sekali saja. Jadi kalau sudah apply sekali, dan sekolah lagi tidak akan bisa memperpanjang length of PGWP.

Ambil master dulu baru apply PGWP ya

PGWP only be given/applied once

PGWP adalah eligibility yg diperoleh dg completing the program,.

Kriteria yg hrs di perhatikan utk proses PGWP

Kriteria utk PGWP:

certificate program in the public school

Lebih baik lulus, kerja dulu better apply PR dulu baru ambil Master

AIPP?

Kalo partner kita adalah Canadian Citizen, maka bisa apply under the family class. Citizen bisa sponsor pasangannya utk jd PR

Setelah bersama for 1 year

PGWP hanya 1x aja jd kalo mau meneruskan sekolah, jangan apply PGWP dulu

Yg eligible to be sponsor adalah kedua parents dan kalo adik hrs dibawah 22 tahun usianya

Anak2 harus jadi eligible kalo dia meet suatu income tertentu baru bisa sponsoring parents.

Lihat table ini ya:

accept your application if you include your 2019 and 2018 NOAs along with it, and submit your 2020 NOA as soon as it's available.

This table applies to you if you live in any province except Quebec. If you live in Quebec, the Quebec ministry in charge of immigration will [assess your income](#).

Note: The numbers below were updated as of May 13, 2021. This update won't affect any of the parents and grandparents applications submitted.

Income required for the 3 tax years right before the day you apply (sponsors applying in 2021)

If more than 7 people, for each additional person, add:	\$6,985	\$8,876	\$8,740

Since many sponsors may have been affected financially by the COVID-19 pandemic, the income requirement for the 2020 tax year has been reduced to the minimum necessary income, instead of the minimum necessary income plus 30%.

Also, family class sponsors will be able to count these benefits in their income calculations for the 2020 tax year:

- regular Employment Insurance benefits (rather than just special Employment Insurance benefits)
- any Canada Emergency Response Benefits issued under the
 - *Employment Insurance Act* or
 - *Canadian Emergency Response Benefit Act*
